TERMS AND CONDITIONS

BACKGROUND:

This agreement applies as between you, the User of this Website or Purchaser and Temerity Media Ltd, the owner(s) of this Website. The Purchaser's order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to the Purchaser indicating that the order has been fulfilled and has been dispatched.

- 2. Interest will be charged on a daily basis, commercial interest at 8% above the base rate of the Bank of England obtaining at the time.

13. Goods, Pricing and Availability

- 1. - 2. Where appropriate, you may be required to select the required [size] [model] [colour] [number] [other features] of the Goods that you are purchasing.

- 2. If the Purchaser sells the Goods on to its own customers in any form, either as purchased from Temerity Media Ltd or forming a component part of a larger Good, and any amount of the purchase price payable to Temerity Media Ltd remains outstanding, the Purchaser must account to Temerity Media Ltd for the proceeds of such a sale. The Purchaser is then required to hold such proceeds on trust for Temerity Media Ltd until payment has been received in full by Temerity Media Ltd.
- 3. Temerity Media Ltd reserves the right to trace all proceeds under the principles of Re Hallett's Estate (1880) 13 Ch D 696. Once the payment date has passed, if any sums remain outstanding, Temerity Media Ltd has the right to enter the Purchaser's premises and remove any Goods which, by virtue of sub-Clause 14.1, remain the property of Temerity Media Ltd.

15. **Delivery**

- 1. Temerity Media Ltd/Gazebos Galore will notify you by way of email when your goods are to be dispatched to you. This notice will contain important delivery information which must be followed.
- 2. If Temerity Media Ltd receives no communication from you, within 1 day of delivery, regarding any problems with the Goods, you are deemed to have received the Goods in full working order and with no problems.

16. **Returns Policy**

Temerity Media Ltd aims to always provide high quality Goods that are fault free and undamaged. On occasion however, goods may need to be returned. Returns are governed by these Terms and Conditions.

- 1. If the Purchaser receives Goods which do not match those ordered, unless accompanied by an explanatory note detailing the changes, stating reasons for the changes and setting out your options, the Purchaser should contact us within 24 hours to arrange collection and return. Temerity Media Ltd is not responsible for paying shipment costs. The Purchaser will be given the option to have the Goods replaced with those ordered (if available) or to be refunded through the payment method used when the Goods were purchased. Refunds and replacements will be issued upon our receipt of the returned Goods.
- If any Goods purchased have faults when they are delivered, the Purchaser should contact Temerity Media Ltd within 24 hours to for advice and should provide digital photographs of the damage. Temerity Media Ltd is not responsible for paying shipment costs. If goods are accepted for return they must be returned in their original condition with all packaging and documentation. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased.
- 3. If any Goods develop faults within their warranty period, the Purchaser is entitled to a repair under the terms of that warranty.
- 4. If Goods are damaged in transit and the damage is apparent on delivery, the Purchaser must sign the delivery note to the effect that the goods have been damaged. In any event, such damage should be reported to Temerity Media Ltd within 24 hours with photographic evidence.
- 5. In all cases, Temerity Media Ltd will provide replacement parts for damaged items. It is not feasible to return large items.
- 6. If the Goods have been dispatched or have reached you, but the Purchaser decides that they are no longer required, the Goods can be returned to Temerity Media Ltd within 24 hours of receipt. Goods can only be returned for this reason if their packaging remains unopened and the Goods can be resold, as new, without any additional work on the part of Temerity Media Ltd. The Purchaser is responsible for paying shipment costs if Goods are returned for this reason. Only the cost of goods will be refunded, less a handling fee.
